What are Applicant Flow Data Metrics Dates?

Metrics Dates are built-in timeframe query items to enable simplified reporting on key metrics within a specific period of time.

There are two types of metrics dates:

- Application Metric Dates: Designed to be used in combination with metrics within the Application Metrics area of the Applicant Flow Data Warehouse (i.e., Applicant Flow, Disability, Ethnicity and Race, Sex), the Application Metric Dates allow for metric aggregation based on the application last submitted date. Timeframe options include both calendar and fiscal year, quarter, and month.
- Vacancy Metric Dates: Designed to be used in combination with metrics from the Vacancy Metrics of the Applicant Flow Data Warehouse (i.e., Vacancy Metrics for Applications, Vacancy Metrics for Certificates), the Vacancy Metric Dates allow for metric aggregation based on the announcement closed date. Timeframe options include both calendar and fiscal year, quarter, and month.

How are Metrics Dates calculated?

Application Calendar Month	The name of the month of the calendar year (e.g., January, February) in which the application was last submitted.					
Application Calendar Month Number	The number of the month of the calendar year (e.g., January = 1, February = 2) in which the application was last submitted.					
Application Calendar Year	The calendar year (e.g., 2020) in which the application was last submitted.					
Application Fiscal Month	The number of the month of the fiscal year (e.g., October = 1, November = 2) in which the application was last submitted.					
Application Fiscal Quarter	The fiscal quarter (e.g., Q1, Q2) in which the application was last submitted.					
Application Fiscal Year	The fiscal year (e.g., 2020) in which the application was last submitted.					
Application Calendar Month	The name of the month of the calendar year (e.g., January, February) in which the application was last submitted.

Announcement Closed Calendar Month	The name of the month of the calendar year (e.g., January, February) in which the announcement was closed.				
Announcement Closed Calendar Month Number	The number of the month of the calendar year (e.g., January = 1, February = 2) in which the announcement was closed.				
Announcement Closed Calendar Year	The calendar year (e.g., 2020) in which the announcement was closed.				
Announcement Closed Fiscal Month	The number of the month of the fiscal year (e.g., October = 1, November = 2) in which the announcement was closed.				
Announcement Closed Fiscal Quarter	The fiscal quarter (e.g., Q1, Q2) in which the announcement was closed.				
Announcement Closed Fiscal Year	The fiscal year (e.g., 2020) in which the announcement was closed.				

How should Application Metric Dates be used?

Application Metric Dates should be used with metrics from the Application Metrics area of the Applicant Flow Data Warehouse and can also be used with data from the Application and Vacancy areas to enable reporting at both the detail and summary levels. Examples of how the metrics can be used include, but are not limited to, the examples below.

Application Metric Date – Summary

Application Metric Dates can be used in combination with Application Metrics and data from the Vacancy area to present aggregate level data for an organization or office.

How should Vacancy Metric Dates be used?

Vacancy Metric Dates should be used with metrics from the Vacancy Metrics area of the Applicant Flow Data Warehouse and can also be used with data from the Vacancy area to enable reporting at both the detail and summary levels. Examples of how the metrics can be used include, but are not limited to, the examples below.

Vacancy Metric Date – Summary

Vacancy Metric Dates can be used in combination with Vacancy Metrics and data from the Vacancy area at the **vacancylevel** (e.g., query items from the Vacancy query subject) or **higher** (e.g., Staffing Organization Name, Staffing Office Name) to present aggregate data.

How should Metric Dates not be used?

Metric Dates should not be mixed with one another (i.e., Vacancy Metric Dates with Application Metric Dates) or with metrics from the other area (i.e., Vacancy Metric Dates with Application Metrics; Application Metric Dates with Vacancy Metrics).
