# Onboarding

- Provides basis for **process standardization** for an organization via **customizable tasks and workflows**
- USA Staffing uses task management to **collaboratively engage multiple users** across functions to be involved in the overall staffing and onboarding process.
- **New hires can complete a wide-array of tasks in USA Staffing:** Forms completion, signature and submission, Document upload, and General task completion, reporting, and date capture using a shared **USAJOBS single sign-on**
- **Over 300 forms are available** including State Tax, Standard and Optional forms, and Agency Specific forms



- **Automatically and electronically transmit** application and onboarding documents to the EHRI eOPF system
- **Access to high quality hiring data through Cognos** including new hire and time to hire data via standard and custom reporting
