System Navigation

Search

- Added the ability for HR users and Onboarding users to quickly search for a New Hire record by entering a partial or full *New Hire Number* in the *Go To* field. Selecting a specific *New Hire Number* from the list of results takes the user directly to the Manage Tasks page within the New Hire record.

Dashboards

Welcome

- Added the option for Human Resources users to include the Position Description *Review Type* in the *Reviews Due* tile. Clicking the review *Title* will take the user to the Review Information page within the selected review.

New Hires and Tasks

- Updated the *Process Owner* filter list to include both active and inactive HR and Onboarding users.
- Added the user email address associated with a user account to dropdown lists on the New Hires and Tasks Dashboard to help users differentiate between accounts with the same name. Users can see this information by hovering over the username in the *Process Owner* dropdown list on the New Hires dashboard and over the username in the *Owner* dropdown list on the Tasks dashboard.

Request

- Added a *History* entry when the *Request Status* is updated to Complete, including the user's name and date/time the request was completed.

Vacancy

- Added an *Appointing Authority* tag titled *STEM 10-year Term*. Agencies can use this tag to identify STEM-related term appointments in the system in alignment with OPM's regulation, which allow agencies to set term appointments for STEM-related positions for up to 10 years.

- Added a specific message that alerts the HR user when the application preview is not available if the announcement has not been released or opened yet to USAJOBS.

Applicant List

- Modified navigation to retain the current page being worked on upon return when users are reviewing an Applicant List and click away from the list; for example, to open an individual applicant record.
- Added the ability to copy an applicant saved list, including all applied filters. The *Copy List* button is displayed after the list is initially saved. Upon copy, the list name will default to “[Original List Name] – Copy”. Users can edit the default list name and edit filters applied (e.g., updating filters to a different grade or location) as needed.

New Hire

- Added the user email address associated with a user account to drop-down lists in the New Hire record to help users differentiate between accounts with the same name. Users can see this information by hovering over the username in the *Onboarding Process Owner* and *Supervisor/Manager* dropdown lists on the New Hire Overview tab and over the username in the *Owner* dropdown list on the Manage tasks page.

- Added a footer to Hiring Manager pages including direct links to newly established pages for the following information:

Administrative Functionality

Applicant List Default Settings

- Added a setting for *CTAP/ICTAP Well Qualified Score* under a new section titled *Applicant List Defaults* that allows users with the *Edit Default Settings* permission to enter a value between 70 and 100. When creating an

applicant list with a *Certificate Type*, the value specified for the office's *CTAP/ICTAP Well Qualified Score* default setting will populate.

Competency Networks

- Redesigned the *Competencies* and *Items* import function, including a new *Import from File* template with added validations to ensure data accuracy. Competencies and items are imported separately from the same workbook with greatly improved overall efficiency and performance, allowing users to import up to 500 records at a time in just a few seconds.

- No updates.

USA Hire Functionality

- Updated the *Edit Window* title to *Edit USA Hire Testing Window*. Also, for clarity, updated the message to “Indicate the time period to complete assessments. If custom values are not manually entered, the system will assign assessment dates that start on the announcement open date and end 2 days after the announcement close date.” and the *Save and Close* button to *Save Custom Window*.
