Staffing Functionality

Dashboard

Welcome

- Added a new tile titled Docs & Forms Ready to Transmit to eOPF. When added to the Welcome Dashboard, this
 tile displays up to ten New Hires with Documents or Forms ready for transmission to eOPF status for which the
 logged in user is the Process Owner. Users can click the new hire name to navigate directly to the Manage Tasks
 page in the New Hire Record for action. This tile can be selected multiple times and the ellipsis icon (...) on the
 upper right corner provides the following additional options:
 - Tile Name Users can change the tile name. This field has a 40-character limit. O Process Owner Users
 can change this value from the default All Users to a specific user.
 - Delete Selecting this option will delete this tile.
- Added a new tile titled *Documents & Forms in Transit to eOPF*. When added to the Welcome Dashboard, this tile
 displays up to ten New Hires with Documents or Forms currently in transmission to eOPF status for which the
 logged in user is the Process Owner. Users can click the new hire name to navigate directly to the Manage Tasks
 page in the New Hire Record for action. This tile can be selected multiple times and the ellipsis icon (...) on the
 upper right corner provides the following additional options:
 - Tile Name Users can change the tile name. This field has a 40-character limit. Process Owner Users
 can change this value from the default All Users to a specific user.
 - Delete Selecting this option will delete this tile.
- Added a new tile titled New Hires without Process Owner. When added to the Welcome Dashboard, this tile
 displays up to ten New Hires without an assigned Process Owner. Users can click the new hire name to navigate
 directly to the Overview tab in the New Hire Record for action. This tile can be selected multiple times and the
 ellipsis icon (...) on the upper right corner provides the following additional options:
 - Tile Name Users can change the tile name. This field has a 40-character limit. Process Owner Users can change this value from the default Unassigned to a specific user. Status Defaults to Active new hires.
 - Delete Selecting this option will delete this tile.

- Added an advanced filtering option titled Forms. This new option allows HR or Onboarding users to filter new hires based on the following Forms statuses.

Certificates

- Added an *Expiration Date* field for each certificate. O Certificates issued in an office where a default expiration date is set in the Applicant List Default Settings page, the certificate expiration date will be calculated based on date the certificate is issued plus the number of days set until expiration (e.g., if a certificate is issued on July 1 and the default expiration days for the office and certificate type is 30, then the expiration date should be July 31.)
 - + If a certificate is issued in an office where a default expiration date is not set, the expiration date will be blank unless a user manually enters a date.
 - **→ Note:** Changes made to the *Certificate Expiration* section of the Applicant List Default Settings will affect certificates issued after the change is made. Changes are not retroactively applied to previously issued certificates. Users with *Issue Certificates* permission can edit a certificates expiration date.
 - o Changes made to the *Expiration Date* are tracked in History.

- The Certificate and Certificates list pages will display an *Expired* label for any certificate that has reached its designated *Expiration Date*. The following business rules apply to expired certificates:
 - Expired certificates cannot be sent in new or existing reviews.
 - Selections cannot be made from expired certificates.
 - → If a certificate expires while it is included in an active review, the Hiring Manager user will be presented with an error message when marking any applicant as Selected.
 - → HR users will be presented with an error message when attempting to audit an applicant with a Return Status of either Hired or Vetting.
 - Applicants cannot be amended (i.e., added, removed, or reordered) within an expired certificate.
 - The Certificate Information cannot be changed within an expired certificate.

Onboarding Functionality

New Hire

- Added a Reason field to the Invitation field on the Overview page within a New Hire record. This field displays
 the reason entered by the new hire when withdrawing from consideration or declining an invitation.

- Added the ability for HR users to see task details in the Assignments > Manage Tasks subpage. Users can click
 each task to see the following detailed information:

Permission Profiles

- Added the ability to retire permission profiles.

 If a permission profile is retired and has never been assigned to a user, it will be deleted from the system.
 If a permission profile is retired and has been assigned to a user, it will be flagged as retired and can be reactivated at any time if needed.
 - If a permission profile is retired and is currently assigned to a user, a warning message will display indicating the permission profile cannot be retired.
 - Note: Retired permission profiles cannot be assigned within a user.

Default Settings

- Added an Applicant List subpage to the Default Settings section in Administration where HR users have the option to set *Certificate Expiration* values.
 - Users can set the number of days after issuance when each of the following certificate types should expire:
 - ★ Ranking Lists
 - ★ Category Rating Certificates
 - ★ Rule of Three Certificates
 - ★ Competitive Merit Promotion Lists
 - **→** Merit Referral Lists If no value is entered, certificates will not expire.
 - All changes made to these default settings are captured in History.
