# **Applicant Flow Data Warehouse**

## **Vacancy Namespace**

### Vacancy Information folder

Requester query subject: a new query subject and query items were added to enable reporting on the requester(s) for any requests associated with a vacancy.

- 'Requester Email': The email address of the requester. Note that more than one requester may be associated with a single vacancy.
- 'Requester Name': The name of the requester. Note that more than one requester may be associated with a single vacancy.

# Hiring Data Warehouse

# **Applications Folder**

## Application Information sub-folder

Application query subject: new query items were added to enable reporting on the status of an application with regard to USA Hire assessments.

- 'Invited to USA Hire?': Flag indicating if an applicant was invited to complete one or more USA Hire batteries ('Yes' only after July 2023 when reporting began, 'No' before).
- 'USA Hire Status': The USA Hire status of an application (e.g., Pending Completion, Partially Complete, Complete, Did Not Complete, Not Applicable).

# **Assessment Packages Folder**

#### Assessment Information sub-folder

Assessment Flags query subject: a new query item was added to enable reporting on the flags associated with an assessment package.

• 'Assessment Flag': The assessment flag associated with the assessment package.

## Assessment Scoring Information sub-folder

Assessment Screen-Outs query subject: a new query subject and query items was added to enable reporting on the screen-out criteria associated with an assessment.

- 'Assessment Screen-Out Ineligibility Code': The ineligibility code (e.g., IQID) associated with the screen-out criteria established for an assessment questionnaire.
- 'Assessment Screen-Out Name': The name of the screen-out criteria established for an assessment questionnaire.

## **AFD Applications API**

The AFD Applications API was updated to include an additional column for application originally submitted date/time.
