OPM employs agile IT development techniques in the development and maintenance of the USA Staffing system. This means we have the ability to update priorities through frequent, iterative releases based on changes in the hiring landscape or the identified needs of the collective customer base.

Staffing Functionality

Dashboard

New Hires

Added the option to search new hire records by email address.

Request

- Added a *Remote Job* checkbox to the Incentives section on the Request Information page. Upon request approval, the setting will flow to the associated vacancy and the following validations are applied:
 - The *Telework Eligible* checkbox is disabled. A job may only be designated as either remote or telework eligible.
 - o Anywhere in the U.S. (remote job) is automatically set as the only available location. This location is exclusive to remote jobs and cannot be combined with other locations.
 - Note: A series of validations and warning messages are enforced and displayed to inform users of these business rules when users make changes to the *Remote Job*, *Telework Eligible*, and/or *Locations* fields.

Vacancy

- Added a *Remote Job* checkbox to the Position Settings section on the Position Information page. When this box is checked, the following validations are applied:
 - The *Telework Eligible* checkbox is disabled. A job may only be designated as either remote or telework eligible.
 - o Anywhere in the U.S. (remote job) is automatically set as the only available location. This location is exclusive to remote jobs and cannot be combined with other locations.
 - Note: A series of validations and warning messages are enforced and displayed to inform users of these business rules when users make changes to the *Remote Job*, *Telework Eligible*, and/or *Locations* fields.

Announcement

- Added the Remote Job field to the Overview section on the Announcement Text page. This field will populate
 Yes/No values based on the selection made in the Vacancy Position Information page. If Remote Job is
 enabled:
 - Users can add an optional description by clicking the edit icon. This description field has a 500character limit.
 - o Also, the *Telework Eligible* field is set to *Not applicable*, *this is a remote position* by default as it will appear on USAJOBS. These fields will display on the Application PDF and JOA Reviews as appropriate.
 - Note: Once an announcement has been released to USAJOBS, the *Remote Job* checkbox cannot be modified to ensure the location and telework business rules are properly applied. We strongly encourage users to carefully review the announcement preview before releasing each announcement.

Applicant Overview

Applicant Record

- Modified the *Updated Application* alert to include a link, which redirects users to the Eligibilities and Ratings page for the specific applicant record.

- The following NOR message code has been added:

Code	Definition	Message
NF	Not moving forward	You are tentatively eligible for this series/grade combination. However, based on the results of the assessment(s) completed so far and the needs of the hiring agency, you are not being moved to the next phase of the hiring process at this time.

Note: Added a corresponding NF Record Status Code (RSC). When the NF NOR message code is applied to an applicant; for example, through an HR override or manual assessment import, the NF RSC will apply. To avoid duplication, the ELNF NOR code, which has the same message as the new NF NOR code, will be removed in a future release.

Applicant Lists

Stored List

• Updated the style of the Stored List Information page and added an *Instructions* section. Users can enter instructions in the textbox or choose an instructional template to be include in the Panel Review by clicking the *Select Instructions* button.

Reviews

• The *Owner* field will default to a blank value in the Review Information page when the previously selected review owner no longer has permission to the vacancy's office.

New Hire

• Added the *Preliminary Acceptance* date on the Overview page within a New Hire record when a new hire accepts an invitation notification type by clicking "Yes, please continue" but does not enter their login.gov credentials to proceed.

- New Hires will see a "No Active Records" message when accessing an inactive or cancelled record via the link included in an *Invitation*, *Tentative Offer*, or *Official Offer* notification.
- Modified the *Credentials Registered Successfully* notification to include the name, email, and department of the *Process Owner* assigned to the New Hire record. If no *Process Owner* is assigned, the email will include the information for the user who sent the *Invitation*, *Tentative Offer*, or *Official Offer* notification.
- When an Additional Agency Contact has been added in the New Hire record, a new section will display in the New Hire Contact Us pop-up information titled Additional Agency Contacts. If a custom title is used for the Additional Contacts field on the New Hire Overview, the custom title will also display. This section will contain the name, email, and phone number for the contact(s) added in the new hire record.

Selective Service System Interconnection

- Created the ability for the Verify Selective Service System Registration system task to automatically assign to eligible new hire records after their initial submission of the OF-306 when they answer yes to being born a male after December 31, 1959.
- Finished the integration work needed to request a new hire's Selective Service Registration status, using data submitted through the OF-306, and update the *Verify Selective Service System Registration* Task Result based on the response received by the Selective Service System interconnection.
- Provided a way for users to manually update the *Verify Selective Service System Registration* Task Result if the interconnection returns a "Not Verified", "Error See Notes", or "Other See Notes" result according to their agency policy.
