Staffing Functionality

Dashboard

Vacancy

✔ Added the following filter options to the Vacancy Dashboard:

- Assessment Type
- Hiring Complete
- USAJOBS Job Title

Request

✔ Added the option to manually enter up to 100 *Request Numbers* when creating and approving Additional Selection requests within a Certificate. Request Numbers entered will be validated against formatting requirements and existing Request Numbers to prevent duplicates. **Note:** Upon submitting requests for creation, the process will run in the background and users will receive an alert when it's completed.

Announcement

✔ Added a *Benefits* section on the Announcement Text page below the Additional Information text field in the Requirements section in alignment with USAJOBS.

Certificate

Increased the number of *Zip Codes* that can be added when filtering a Certificate from five to a maximum of 30.

Added the name of the user who added or removed an applicant from a certificate to the Certificate Amendments modal. Also, added the ability to search for a specific applicant by name.

Onboard

Updated the Onboard help content platform and migrated content to a new software named Zendesk for improved user experience. New hires will benefit from faster page loads, enhanced navigation, higher-resolution images, and improved search capabilities when accessing online help from the Onboard interface.

Added hyperlinks to the email and phone fields in the Contact Us modal within the Onboard interface, which allows new hires to instantly call or email their point of contact via their default email or phone application.
