- The rules of behavior that are agreed to following the creation of a user account have been updated to include additional information about the use of Applicant Flow Data and USA Hire assessments in the USA Staffing Upgrade.

VACANCY

October - USA Staffing now automatically designates an expiration date for each vacancy. The expiration date is added to the vacancy following the issuance of the first certificate. The date is calculated as 365 days following the issuance of the last certificate. Each time a new certificate is issued, the date recalculates. The date may be updated manually by any user with permissions to update the status of the vacancy. The vacancy will be automatically moved to expired when reaching the expiration date.

APPLICANTS

• The gear icon located on the Applicant Overview page now provides an option for "Send Global Notification." This option will trigger the selection of a notification template to be sent to all applicants to the vacancy. Rules regarding editing of notifications by template type still pertain. This notification capability is intended for use when an entire applicant pool needs to be aware of something, such as the cancellation or extension of an announcement.

ASSESSMENT

• HR users can now search for an Assessment Package Template by individual assessment name or assessment ID number.

REPORTS

- Applicant Touchpoints by Vacancy report has added to Cognos. Applicant touchpoints are notifications sent to the applicant, including Acknowledgement, Notification, NOR and Disposition Letters.
- Vacancy notes are now in Cognos, and users can report on this data.

ADMINISTRATION

- Updated notification and announcement data inserts to account for the internal and external customer names. The previous data insert for "Customer Name" is now labelled "Internal Customer Name." A new data insert for "External Customer Name" was added for use.
- Added an additional Tag Type for use called "Mission Critical Occupations." There are six standard system Mission Critical Occupation tags available including STEM and Cyber Security. Custom mission critical tags may be created and used by office.

- Added a banner to Applicant Flow Data Only user accounts to warn users creating and managing these
 accounts that AFD Only users should not be given access to both staffing capabilities and Applicant
 Flow Data. The use of applicant flow data is to be limited to EEO professionals that are not executing
 the staffing function in USA Staffing.
- We have blocked the use of placeholder text in administrative content that cannot later be updated by HR users during the staffing process. This includes touchpoint notifications and eligibilities.
- Coctober Custom Tags may now be retired from the Manage Tags section in administration. Retiring tags will not remove a tag from administrative content but will ensure that the tag can no longer be assigned to content in the future.

ONBOARDING/NEW HIRE

- Onboarding User types are no longer able to create 'New Vacancy' or 'Additional Selection' requests.
- HR Users with permission to manage default settings are able to specify what address should populate for all new hires created within a specific office. Users may specify the Office's address, Customer's address, or a Custom Address.

- Updated versions of these government-wide forms were published: SF-61 and TSP-19.
