Advanced Search

✔ Updated Advanced Search to include a new user interface, extensive performance improvements, and the ability for users to modify their results options. Dashboard

Tasks and New Hires

Enhanced user experience and usability by replacing filters on both dashboards with newly designed filter side drawer, which contains expandable/collapsible sections.

- Drawer opens automatically when first accessing the dashboard until filters are applied, and then remains closed until the *Filter(s)* button is clicked.
- Default filters remain the same (i.e., Set to *Active Status* and *Owner* on the Tasks Dashboard, and *Onboarding Process Owner* on the New Hires Dashboard).
- Filters are retained and automatically applied when navigating to/from dashboard within the same session. <https://help.usastaffing.gov/USAS/index.php?title=Tasks>

New Hire

Selective Service System Interconnection

✔ Granted users with the *Edit Task Details* permission the ability to manually trigger a single TaskUpdate API request to the Selective Service System Interconnection when the integration initially returns an error result response. Users can click the *Refresh Result* link underneath the Task Result in the Verify Selective Service Registration task details area of the new hire record.

✔ Added validation to the *Social Security Number* (SSN) field in the onboarding interface for new hires. New hires will be required to enter their SSN and confirm it, and both values must match before they can proceed, to increase security and accuracy.
