Modified the *Review Assignments* to no longer assign the requesting Hiring Manager as a Subject Matter Expert (SME) Reviewer when creating an SME review. HR users may still manually assign the *Requester* if they would like the Hiring Manager to be involved in the review process.

Selective Service System Interconnection

Added a new response of *Pending Further Action* to the *Task Results* field for the *Verify Selective Service System Registration* task to allow for a more accurate status of the registration verification process.

Changed the *Task Result* associated with existing error codes to help prepare the system to allow for Users to manual retrigger the interconnection when a true error occurs:

- If the integration results in Error 999, the *Task Result* will now be updated to *Error - See Notes* and display the currently associated task note: "The Selective Service interconnection system is currently experiencing technical difficulties (code: {#}). Follow your agency policy to continue with verification."
- If the integration results in Error Code 91 or 92 the *Task Result* will now be updated to *Other - See Notes*, the corresponding message from the Selective Service System will continue to display the currently associated task note:
 - Error 91: "There are no records in the Database before January 1, 1960"
 - Error 92: "To register for Selective Service you must be at least 17 Years Old"
