 - Announcement Questionnaire Information sub-folder: a new query subject and associated query item was added to enable reporting on the rating combination for which an announcement questionnaire screen-out item applies.
 - Announcement Screen-Out Rating Combinations query subject
 - 'Announcement Screen-Out Rating Combination': The rating combination (e.g., 0201-07) for which the announcement questionnaire screen-out criteria is applicable.
