## Staffing Functionality

### Vacancy

- Added a system-level Mission Critical Occupation (MCO) tag titled *Infrastructure Act* to the Vacancy Settings page. Using this system-level tag helps ensure consistent reporting within and across agencies. Visitors to the USAJOBS website will see an alert on the home page and all search results pages highlighting these job opportunities. **Note:** This tag will be available to use in Production on November 29, 2021 and can be added to both new and existing vacancies. Users must remember to update their announcements on USAJOBS when adding the *Infrastructure Act* MCO tag to an existing vacancy.

### Announcement

- Updated the Announcement Text page (as well as the Announcement PDF, Agency Marketing sub-templates, and Job Opportunity Announcement Review) to add a second *Marketing Video Link* field, which allows users to add up to two videos embedded in the Videos section of the USAJOBS announcement.

- Added a *History* entry on the Announcement Information page to capture edits made to the *Linked JOA Control Number* for announcements that have been released to USAJOBS.

### Assessment Package

#### Assessment Questionnaire

- Completed the following usability improvements on the Item Weights pop-up window on the Rating Criteria page within an Assessment Package and Assessment Package Template:
  - Removed the sort capability from all headers.
  - Added specialties in parentheses next to each rating combination in the Rating Criteria page, if applicable.
  - Added a *Response Type* column between the *Item Stem* and *Rated* columns.
  - Replaced the *Apply to all Rating Combinations* checkbox with a button.
  - A warning banner is displayed to inform users if they have unsaved changes when an item's proportional weight or a response item's base value is adjusted either manually or by clicking the *Apply to all Rating Combinations* button.
  - The following confirmation message is displayed when an HR User clicks the *Apply to all Rating Combinations* button to override an item's proportional weight, individual response base values, and/or rated checkbox indicator across all rating combinations: "This item's rated status, proportional weight, and response values have been applied to all other rating combinations. You must click Save to retain these changes."

- Added the ability for HR Users to copy up to 100 *Reviewers* and 10 *Followers* when creating a copy of a review.

- Added the ability for HR Users to delete reviews that have never been sent. The review will be removed from any corresponding areas.

- Updated the *Show Announcement* button to display *Preview Announcement* in JOA Reviews. Selecting *Preview Announcement* will display the USAJOBS *Preview URL* created by HR. Clicking the URL will open the announcement preview in a new browser tab.
