OPM employs agile IT development techniques in the development and maintenance of the USA Staffing system. This means we have the ability to update priorities through frequent, iterative releases based on changes in the hiring landscape or the identified needs of the collective customer base.

Staffing Functionality

Dashboard

Welcome

- Added a new tile titled Forms Awaiting HR Action. When added to the Welcome Dashboard, this tile displays up to ten New Hires with forms ready for HR action for which the logged in user is the Process Owner. Users can click the new hire link to navigate directly to the Forms page in the New Hire Record for action. This tile can be selected multiple times and the ellipsis icon (...) on the upper right corner provides the following additional options:
 - \circ Tile Name Users can change the tile name. This field has a 40-character limit. \circ Process Owner
 - Users can change this value from the default logged in user to any specific user. \circ Form Status
 - Defaults to Any. Users can filter the tile results by each of the following statuses: + Pending

- + Released Delete Selecting this option will delete this tile.

Added a new tile titled *Documents & Forms with eOPF Errors*. When added to the Welcome Dashboard, this tile displays up to ten New Hires with documents or forms with eOPF transmission errors for which the logged in user is the Process Owner. Users can click the new hire link to navigate directly to the Manage Tasks page in the New Hire Record for action. This tile can be selected multiple times and the ellipsis icon (...) on the upper right corner provides the following additional options:

o Tile Name – Users can change the tile name. This field has a 40-character limit. O Process Owner – Users

can change this value from the default logged in user to any specific user.

Vacancy

Added the COVID-19 system-level *Mission Critical Occupation* tag to the Vacancy Settings sub-page. Using this system level tag helps ensure consistent reporting within and across agencies. Also, USAJOBS uses this tag to include announcements in the following COVID-19 response page https://www.usajobs.gov/coronavirus. Visitors to the USAJOBS website will see an alert on the home page, all search results pages, and the Explore Opportunities tab directing applicants to these job opportunities. USAJOBS recommends users include the following text in the Duties (or any other appropriate) section of the announcement: "This position will support the Federal Government's response efforts to COVID-19." to ensure the announcements are properly included in Search results. Note: This tag is now available in Production and can be added to both new and existing vacancies. Users must remember to update their announcements on USAJOBS when adding the COVID-19 tag to an existing vacancy. https://help.usastaffing.gov/USAS/index.php?title=Available_Tags

Online Application

 Added a remaining characters indicator for narrative answer questions to better inform applicants of the specified character limit during the application process. https://help.usastaffing.gov/Apply/index.php?title=Assessment

Applicant List

- For vacancies with the Collect age information option enabled on the Vacancy Settings sub-page, users with View Announcement Questionnaire Answers permission will see an Age Screening tab after expanding an applicant record within an applicant list. This tab displays the following information:
 - \circ Date of Birth \circ Job Related Experience This section will display when the Use Effective Age setting is

enabled on the

Vacancy Settings sup-page. Users with Edit Eligibility, Preferences, and Custom Answers or Create Key Entered Applicant permission will have the option to edit the number of months directly from the list, if applicable. Once the change is saved, the record will be re-rated and the following will occur:

- + The override triangle icon will display indicating this field was edited.
- + History of the change will be captured in the applicant record.
- An exclamation icon ! will appear next to the applicant's name letting the user know they need to refresh the list to update the effective age. <u>https://help.usastaffing.gov/USAS/index.php?title=Editing_job_related_experience</u>

Certificates

- The Certificates tab has been defaulted to display the list of certificates by *Issue Date* in descending order with the most recently created certificates appearing at the top. <u>https://help.usastaffing.gov/USAS/index.php?title=Certificate_Overview</u>
- Users will no longer have the option to inadvertently create new hire records from an expired certificate that
 has already been audited with one or more selections or alternate selections; more specifically:

 The Hired
 and Vetting return statuses will not be available for an individual applicant audit.

• The Vetting return status will not be available when auditing multiple applicants simultaneously.

Onboarding Functionality

New Hire

- Added the Announcement Number to the Overview tab within the New Hire record for new hires selected/hired from a certificate. Users can click this link to navigate directly to the Announcement tab. <u>https://help.usastaffing.gov/USAS/index.php?title=New_Hire_Overview</u>
- Added a new section to the Overview Tab titled "Additional Information." This section contains a box where a
 user can add, update, and remove Tags for the New Hire record. At this time, the tags are limited to "Appointing
 Authorities" and "Mission Critical Occupations" tags. Multiple tags can be assigned to a single record and
 changes to tags are tracked in the history for the Overview tab. NOTE: Tags from associated Vacancies and
 Requests will not automatically flow to New Hire records at this time. This functionality will be coming in a
 future release.

 New Hires attempting to upload a document exceeding the file name character limit (100 characters including spaces), will receive an error message preventing them from uploading the document and prompting them to try again. This will prevent errors when Onboarding users attempt to view the document during their review process.

Classification Functionality

Position Description

Users with Create/Edit Position Descriptions permission for the Owning Office (or any other tagged offices) will see a new *Copy Position Description* option under the gear icon within a position description (PD). When users select this option, the system will create a draft copy of the PD record. The *Position Description Number* will prepopulate with *Copy of* in front of the copied *Position Description Number* to ensure uniqueness. Users can update the PD number once the copy is created. The PD copy will include any attached documents and most of the fields across the various sub-pages with the following exceptions: o Date of Position Approval Linked Position Descriptions
