- Added an advanced filtering option titled Invitation/Offer Response. This new option allows HR or Onboarding
 users to filter new hires based on the response received for invitations or job offers, and quickly find new
 hires that may need further action or follow-up. The following response types are available:

instructions on how to substantiate their claim with the reasonable accommodation adjudication team. Note:
This change will apply to new announcements not yet released/open on USAJOBS.

Applicant List

- Rearranged action buttons on the Applicant List page to place items in a more logical location for use:
 O Moved the
 "Save List" button to the top of the page.
 - Moved the "Create Stored List" option from the gear icon to a button on the top right of the page, titled
 "Generate Stored List." O Moved the "Show Application Number" checkbox from the top of the page to the gear icon.
 - Moved the "Display Preferences for Applicant List" button to the certificate's header.

New Hire

• For each new hire, a single draft can be saved per notification template name. Users will be prompted if an existing draft exists for that template and given the option to create a new draft or edit an existing draft. Users can share the new hire and template name with any other users they wish to have review or send to the new hire.
