OPM employs agile IT development techniques in the development and maintenance of the USA Staffing system. This means we have the ability to update priorities through frequent, iterative releases based on changes in the hiring landscape or the identified needs of the collective customer base.

Dashboard

New Hire

• Added the option to search New Hire records by *New Hire Number* in addition to *Name* or *Start Date* on the New Hires Dashboard search field. Requests

Added the Edit Request Dates After Approval permission to the Onboarding User Permission Profile type.
 Administrators can now grant Onboarding User types the ability to update the Hiring Need Validated Date and
 Request Personnel Action Date after a Request is approved. This permission is toggled off as a default for all
 system level onboarding profiles and custom profiles created prior to this release.

Announcement

- Updated the buttons to copy content from a vacancy or announcement sub-template on the Announcement Text page to align with the announcement sub-template updates in Administration:
 - o Renamed the *Copy Duties* button to *Copy Summary & Duties*.
 - Moved the Copy Summary & Duties button to the Summary section from the Duties section.
 - Users can select the Copy Summary & Duties button to copy Summary, Responsibilities, and Duties from a vacancy or from the Summary & Duties sub-template to the announcement.
 - Renamed the Copy Position Requirements button to Copy Requirements.
 - Users can select the Copy Requirements button to copy Requirements, Conditions Of Employment, Qualifications, Education, Display Default Accredited Education Text, Additional Information, Benefits Link, and Display Default Benefits Text from a vacancy or from the Requirements sub-template to the announcement. https://help.usastaffing.gov/USAS/index.php?title=Announcement Text

Assessment Questionnaire

The system will allow users to click a checkbox in the Add Questionnaire Item pop-up that will select all of an item's responses. Users will then be able to delete responses in mass as needed.

Certificates

• When an HR user elects to send a batch of New Hire email notifications from a certificate, the Notification Preview Screen will be replaced by a banner message to the HR user informing them that sending of New Hire notifications has been initiated. When all notifications have been sent, the system will display a user alert and send an email to the HR User who sent the notifications. The email will include the vacancy number, job title, certificate number, the count of New Hire notifications sent successfully, and the name(s) of the New Hires with failed notifications.
