Dashboard

Tasks

- Added the ability to search by Task Name on the Tasks Dashboard. Results will contain any whole or partial matches applicable and related to filters previously applied.

Announcement

- Added the ability to copy the *Agency Marketing* section of an announcement from an existing vacancy or new template type. This section will now display a *Copy* button in the Announcement Text page.
 - When users click this button, they will see the following options:
 - *From Vacancy* – Selecting this option will present a field to enter a vacancy number from which to copy the *Agency Marketing* section. The following content will be copied:
 - *Marketing Message*
 - *Marketing Link*
 - *Marketing Video Link*
 - *Benefits Link*
 - *Display Default Benefits Text* checkbox
 - *From Template* – Selecting this option will insert the template data in the appropriate sections.
 - If there are no templates for the associated template type in the Announcement Template library, *From Template* will not be listed as an option.
 - If text had been previously entered in any of the sections, the existing text will be overwritten upon user confirmation.
 - Whether content is copied from a vacancy or template, everything will be copied over exactly as it is when the content is copied; including text, style, data inserts, placeholder text, links, etc.
 - The *Copy* button will no longer display once an announcement is released and open. If the announcement is removed from USAJOBS, they will once again be available. See the [Administrative Functionality](#) section below for information on this new announcement template type.

Applicant Overview

Applicant Record

- Added a *New Hire Document Type* field that gives HR or Onboarding users the option to properly categorize documents designated as NH Viewable within an applicant record. Users with Edit Documents permission can click the gear icon next to the document and will see this new field under the Manage Document section. Changes will be captured in History. Upon new hire creation, documents that have been set as NH Viewable and categorized using the appropriate Onboarding document type will flow into the new hire record based on the *New Hire Document Type* set in the Applicant Record.

- The following NOR message codes have been added:

Code	Definition	Message
IAOM	Ineligible for Overseas Military Spouse Preference	You were not considered because you are not eligible to apply as an Overseas Military Spouse Preference candidate until you have arrived within the commuting area of your sponsor's new duty station.
ELCS	Eligible for DHS Cybersecurity Service	You have completed the mandatory assessments for the DHS Cybersecurity Service, and you may be referred to a hiring manager to be considered for a position that matches your background.
IFAO	Missing documentation of military flight experience	You were not considered because you did not provide the aeronautical order, forms, or logbooks to verify your military flight experience as specified in the announcement.

Applicant List

- Added an Expiration Date option in the *Application Date* field to filter applicant lists. This option will be available when the *Expire applications following the period of eligibility* box is enabled within the Vacancy Settings page. When the Expiration Date option is selected, and a date range is entered, applicants expiring on/between the dates entered will be included in the list considering any other filter(s) applied.

Certificates

- ✓ When a certificate is expired/unexpired, the system will re-evaluate each applicant's Record Status Code (RSC) and update as appropriate. If a user modifies the *Expiration Date* on a certificate, they'll be presented with the following message: "The Record Status Codes for the applications on this certificate will be updated in the background. This process may take a few minutes to complete, depending on the number of applications."

Reviews

- Added pagination to the Reviews tab for improved performance when there are 31 or more reviews within a vacancy. Additional results will display in a separate page. Users can navigate back and forth between pages using the pagination options at the bottom right of the page.
- Added the ability to search reviews in the Reviews tab by Review Name and Reviewer Name.
- Added a *Review Statuses* filter on the Reviews tab that allows users to filter reviews by status:
 - Active
 - Not Sent
 - Recalled
 - Returned

Onboarding Functionality

New Hire

- HR and Onboarding users will see the name of the user who completed the Verify the New Hire Arrived for their First Day of Duty task and the date and time the task was completed at the bottom of the Overview tab

within a record in which the Verify the New Hire Arrived for their First Day of Duty task is in Complete status. This information will display in the following format:

- *Verify the New Hire Arrived for their First Day of Duty task completed by [First Name Last Name on XX-XX-XXXX]*

Announcement Templates

- Added the ability to create an Agency Marketing template type. This allows users to use an existing template to populate the *Agency Marketing* section of an announcement as described in the [Staffing Functionality](#) section above. When creating an announcement template, users will see Agency Marketing listed as an option in the *Template Type* field.

Workflows

- When creating/editing a workflow with the *Purpose* of Staffing and electing to add a task rule, users will see a new system event titled Announcement Closed in the *Activate task when [Select a system event]* field. This rule will set the specified task to active status when the announcement closes.
