OPM employs agile IT development techniques in the development and maintenance of the USA Staffing system. This means we have the ability to update priorities through frequent, iterative releases based on changes in the hiring landscape or the identified needs of the collective customer base.

# **Staffing Functionality**

#### **Dashboard**

#### Welcome

- Replaced the Task Totals tile with the *Task Counts* tile in the Tile Library. The Task Totals tile will no longer be available for selection on the library or displayed on any dashboard where it had been previously selected. The new *Task Counts* tile is a collection for four grouped tiles that act as a single tile. This new tile enables users to display counts of active tasks based on configurable task filters. This tile can be selected multiple times and the ellipsis icon (...) on the upper right corner provides the following additional options for each count:
  - Tile Name Users can change the count name. This field has a 40-character limit. Owner Users can change this value from the default of the user logged in to another user. O Task Type Users can select a specific type from the list.
  - Due Date Users can select a date range of up to +/- 10 days from the current date. The default settings for each count are:
    - Overdue Active Tasks and Unassigned Requests Tiles Due Date between -10 and yesterday.
      - ◆ Upcoming Active Tasks and Unassigned Active Tasks Tiles Due Date from today +10 days. Purpose Users can select to view counts related to Staffing and/or Onboarding tasks.
  - Delete Selecting this option will delete all four grouped tiles.

#### **Tasks**

Added the ability to hover the Vacancy Number for each task to see the following additional information: 
 Pay Plan-Series-Grade

- Office This is the office to which the vacancy is assigned
- Added the ability to hover over the Request Number for each task to see the following additional information:
  - Request Number o Pay Plan-Series-Grade o Internal Customer Name

     New Hire
- Added an advanced filtering option titled *eOPF Transmissions*. This filter allows users to narrow new hire records by the following transmission statuses to take appropriate action:
  - Files Ready to Transmit Results will include only new hires which have forms or documents that are transmittable and the status is *Ready to Transmit or Elected Not to Transmit*.
  - Files Being Transmitted Results will include only new hires that have forms or documents with a transmission status of *Queued* or *Transmitted*.
  - Files with Errors Results will include only new hires where there are forms or documents that have been transmitted and resulted in a transmission status of *Errors*. https://help.usastaffing.gov/USAS/index.php?title=New Hires

#### Request

When creating an Onboard New Hire request, users will now be required to select an Office when more than
one option is available on the New Hire subpage. Note: For users with permissions associated with only one
office for the selected Customer, the Office field will auto-populate. For users with permissions associated
with more than one office for the selected Customer, the Office field will be left blank, and the users must
select an office before the request can be approved.

#### Vacancy

Users will now be able to edit the Case File Retention and Vacancy Tags sections of a vacancy's Settings page
after a vacancy is moved to Cancelled or Expired status. Note: Any changes made to these fields after
expiration or cancellation will be captured in History if the announcement was ever released and open.

#### **Assessment Package**

#### **USA Hire**

Clarified the question text applicants receive when requesting reasonable accommodation for USA Hire
assessments by explaining the difference between accommodation for online assessments and
accommodation for the job. Additionally, the question text changes provide applicants who answer
affirmatively to this question instructions on how to substantiate their claim with the reasonable
accommodation adjudication team. Note: This change will apply to new announcements not yet
released/open on USAJOBS.

Re-labeled the Open/Close Dates button to Set USA Hire Assessment Window, and improved the design of the pop-up to provide a clearer and more intuitive user experience.

#### **Applicant List**

• When a vacancy is set to screen applicants based on age on the Vacancy Settings page, a new column titled Age will now display on the Applicant List so that users can more effectively monitor when applicants are approaching an age cutoff. The age will display in years, months, and days format. Note: The Age is only displayed on applicant lists, not on stored lists or certificates, and it is not a sortable or filterable value. ## **Online Application**

Updated the Choose Locations question presentation for applicants. When over 100 locations are added to an
announcement, the checkbox selection list will transform into a drop-down list where applicants can add the
locations for which they want to be considered. This drop-down list option is the same style used on the

#### **Certificates**

• Made usability changes to the functionality for creating additional requests within the Certificate page. When users click the *Create Additional Requests* button, they will now be prompted to indicate the number of additional requests they would like to create before proceeding. Users can select to create up to 10 requests at a time. The rest of the process remains the same.

#### **New Hire Record**

- When editing a new hire notification, the system will now retain any attachments added prior to editing the notification.

- New Hires will be prompted to login for each new session. This is to prevent new hires who may inadvertently
  do work in someone else's account when sharing computers.

- Added the form numbers to the lock icon rollover on the new hire questionnaire. This information will be available to both new hires, and HR/Onboarding users.

- Removed questionnaire topics from HR view within a new hire record when there are no questions associated with it.

- Made the following usability improvements to the Return for Correction window. When users elect to return a form to the new hire for correction for a submitted form, they are presented with a prompt to select the question(s) that need to be corrected using the following criteria:
  - ★ Assigned questions that are directly associated with the form version assigned. If the user only selects a question that is directly associated with the form and elects to continue, the system will return all forms assigned to the new hire that are directly associated with the question.
  - ★ Child items of assigned Item Group or Filtered Item Group questions. If the user only selects a question that is indirectly associated with the form (child item of a FIG or IG), the system will return all forms assigned to the new hire that are directly associated with the questions' parent item (FIG or IG).

The new hire record will now retain the original completion date of the Send Tentative Offer and Send Official
Offer tasks when multiple notifications are sent prior to a new hire's acceptance. This will ensure more

## **Hiring Manager Functionality**

When selecting multiple applicants to audit at once, the system will now display the names of applicants included in the selection decision so HM users can quickly see what applicants they are adding a hiring decision for and have the ability to remove applicants if applicable by clicking the X icon next to their name on the window.

### **Administrative Functionality**

#### **Users**

Added a checkbox titled Applicant Flow Data Access under Account Details. When this box is checked, applicant flow data access will be granted to HR Users and Reports Only Users all offices to which the user has access. Note: AFD users will continue to have access to data, without the need to have this new field checked. The long term plan is to move all AFD access to HR and Reports Only user types, and remove the ADF Only user type from USA Staffing.

#### **Position Descriptions Library**

- Renamed the Position Sensitivity field on the Position Information page to Position Sensitivity and Risk. Also, updated the values presented in this field to align with USAJOBS and the Request and Vacancy areas of the system. Only one value can be selected from the following options: Blank option (default) Previously Not Designated Non-sensitive (NS)/Low Risk (1) Previously Non-Sensitive (NS) National Security Risk and Low Risk (LR) Public Trust Position Noncritical-Sensitive (NCS)/Moderate Risk (2) Previously Non-Critical Sensitive Critical-Sensitive (CS)/High Risk (3) Previously Critical Sensitive Special-Sensitive (SS)/High Risk (4) Previously Special Sensitive Moderate Risk (MR) (5) Previously Public Trust-Mod Risk High Risk (HR) (6) Previously Public Trust-High Risk NCS/High Risk (7)
