Staffing Functionality

Assessment Package

- Added a *Clear Assessment Package Content* option under the gear icon in the Assessment Package. This option gives users with Delete Assessment permission the option to completely clear the assessment package content (except for the category settings and attached documents) given the assessment package is not marked complete, and the announcement has not been opened/released to USAJOBS. If this option is selected, users will be presented with the following confirmation message: *"This action will remove all Assessments, Test Scenarios, and Job Analysis information. It will also restore default Categories, if applicable for this office. Are you sure you want to clear the Assessment Package information?"*

Applicant List

- Users can open the Rating Details window by clicking the rating link under the *Rating* column within an Applicant List or Saved List to make any necessary changes to the rating details for a specific applicant. This replaces the need to expand the row and click the edit icons for each item.

Certificates

- Added the ability to filter certificates by Veterans' Preference, Audit Code, and/or Return Status under the *Add Filters* button to facilitate finding applicants within multi-page certificates.

Onboarding Functionality

New Hire

- Users attempting to delete a New Hire Interconnection (NHI) trigger task will be presented the following warning message to ensure they do not unintentionally prevent data being properly sent via the NHI: *"You have selected one or more tasks used to trigger an interconnection. Deleting these tasks may prevent data from being sent to the interconnected system. Any forms associated with the selected tasks will be unassigned from the New Hire. Would you like to continue?"* Users will have the option to cancel or proceed.

- Added the ability to apply system-level or custom Appointing Authorities and/or Mission Critical tag types to New Hire records to facilitate search and reporting capabilities. The *New Hire Tags* field is located under the Additional Information section on the Onboarding Information sub-page of the Overview tab.

- Added the following forms in USA Staffing: ○ BIE FCRA – Fair Credit Reporting Act, SBA ROB-CU – Rules of Behavior Computer Usage

Hiring Manager Functionality

Position Description Library

- Created a library for Hiring Managers to search and view position descriptions (PDs) that are published by HR in the Classification module. Hiring Managers with any of the System-level Hiring Manager permission profiles will have access to the PD Library by default. Office Administrators must enable this capability on Custom permission profiles.
- Hiring Managers may search for PDs based on the PD number, position title, series, or grade. •
Search results include the following: ○ Position Title ○ Pay plan – Series – Grade ○ PD Number
○ A preview of the Introductory Statement, if applicable ○ Last Modified date

- The ability to view a PDF version of the PD, including all fields entered in the source PD. This is the same 'View PDF' option that HR users have within the classification module.
- The ability to view documents attached to the PD

Administrative Functionality

Notification Templates

- Added an *Announcement Number* data insert to Onboarding notifications under the Position available data inserts section.

- Added the ability for users with the Retire Notification Templates permission to retire Onboarding Notification Templates.
 - When users click the *Retire* button, the system will flag the notification as retired. ○ Retired notification templates cannot be selected within New Hire records.
 - Retired notification templates can be viewed in the Notification Templates library by selecting the *Show Retired Templates* checkbox. Clicking this checkbox will show the Notification Templates in the list with the *Is Retired* column populated.
 - Notification Templates become read only once they are retired. Users with Retire Notification Templates permission can reactivate a retired notification at any time by clicking the *Reactivate* button within a template. These changes are captured in the *History* section for each template.

- Added the *Task Name* in the Define and Add Task Rules window title for context when setting activation and/or completion rules for a specific task within a workflow.

Classification Functionality

Position Description

- Added a new option under the gear icon in the Position Information page titled *PD Package PDF*. Users with access to Position Descriptions will have the option to print a combined PDF of the Position Description including the PD Cover Sheet, Position Description, and Evaluation Statement.

USA Hire Functionality

- Users will see the following warning message in the Assessment Package Checklist when a multi-grade vacancy contains an assessment package including a USA Hire assessment for some but not all grades: "*Assessment Plan*

does not include an external assessment for all grade levels. Please review and correct if needed." This warning is intended to better inform users of applicable USAH assessments per grade and encourage them to make any necessary changes, if applicable.
